

**THE CORPORATION OF THE VILLAGE OF BURK'S FALLS
BY-LAW NO. 12 -2005**

**Being a by-law to control the use of the
Operation of skateboards in the Village of Burk's Falls**

WHEREAS, Paragraph 11(1), s.s. 2, of the Municipal Act, S.O. 2001, c. 25 as amended provides that municipalities may pass by-laws respecting matters within their jurisdiction relating to transportation systems, other than highways;

AND WHEREAS Paragraph 130, of the Municipal Act, S.O. 2001, c. 25 as amended provides that a municipality ay regulate matters not specifically provided for by this Act or any other Act for purposes related to the health, safety and well-being of the inhabitants of the municipality;

AND THAT it is deemed expedient in the public safety to control the use of the operation of skateboards within the Municipality of the Village of Burk's Falls for the protection of all inhabitants.

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE VILLAGE OF BURK'S FALLS ENACTS AS FOLLOWS;

1. **That** no skateboard, or similar device, shall be used, or operated by any person on any sidewalk or public property within the Village of Burk's Falls.
2. **That** for the purpose of this by-law a skateboard shall be defined as any device self-propelled by the operator, and consisting of a frame or board, wheels and without mechanical steering or brakes.
3. **Every** person who contravenes any of the provisions of the By-law is guilty of an offence as is liable upon conviction thereof to a fine as set out in Schedule "A" attached hereto.
4. **The** By-Law Enforcement Officer may seize the skateboard from any person he has reasonable grounds to believe is under the age of 18(Eighteen) and is operating a skateboard in contravention of this by-law.
5. **Repeals** By-laws 22-1998, 7-1996, 16-1990.

This By-law shall come into force and take effect immediately upon passing.
